

Livingston Parish Library Board of Control Regular Meeting, January 25, 2022

Minutes

The Livingston Parish Library Board of Control met in regular session on January 25, 2022. The meeting took place at the Denham Springs-Walker Branch, located at 8101 LA Hwy 190, Denham Springs, LA 70726.

1. Call to Order

Board Vice-President, Kathy deGeneres, called the meeting to order at 5:10 p.m.

2. Roll Call

3. Approve Minutes of November 15, 2021 meeting

Motion by Stephen Link, seconded by Erin Sandefur to waive the reading of the minutes and approve as presented, passed unanimously.

4. Public Comments of Items on the agenda

5. Unfinished Business

a. Administrative positions

Review of job descriptions proposed by Giovanni Tairov to create and hire a second assistant director position and rename the position of the current assistant director. Motion by Stephen Link, seconded by Erin Sandefur to accept the proposed job

descriptions of Assistant Director of Branch Services and Assistant Director of Support Services. Motion passed unanimously.

6. New Business

a. Election of Officers

b. Administrative Building Expansion Project – Review of bids, Request to accept low bid
